CONDITIONS OF SALE

1. Advanced bids in the mail or over the telephone must be accompanied by a 25% deposit. Credit Cards are not acceptable for absentee bids.
2. Terms: Cash or check provided by the Purchaser is accredited by the auctioneer.
3. While Tim's Inc. has endeavored to catalogue and describe the property correctly, all property is sold "as is" and neither Tim's Inc. nor its consignor will be responsible for the description, genuineness, provenance or condition of the property. No statement contained in the catalogue or made orally at the sale or otherwise shall be deemed to be such a warranty or representation or an assumption of liability. All property is available for inspection by the Purchaser at the Preview prior to the auction.
4. Tim's Inc. reserves the right to withdraw any item at any time before the sale.
5. The highest bidder acknowledged by the auctioneer shall be the purchaser. In the event of any dispute between bidders, the auctioneer shall have absolute discretion to determine the successful bidder, in which event this determination shall be final, or to re-offer and re-sell the article in dispute. If any dispute arises after the sale, Tim's Inc. sale record shall be conclusive as to who was the Purchaser, the amount of the highest bid, and in all other respects.
6. When the auctioneer says "sold" title to the property will pass to the bidder acknowledged by the auctioneer. The bidder thereupon assumes full risk and responsibility and will pay the purchase price for such property by completion of auction. Purchasers are responsible for items purchased by their number.
7. The Purchaser agrees to pay a 25% premium and the applicable sales tax in addition to the sales price. 25% premium for checks.
8. The auctioneer or a representative of Tim's Inc. may act in behalf of absentee bidders, that is non-present bidders who wish to participate as bidders/buyers in the auction by leaving bids on particular items.
9. Tim's Inc. does not provide storage. Any cost incurred by Tim's Inc. in transporting or storing property after the sale shall be borne by the Purchaser.
10. Tim's Inc will facilitate shipping of certain items purchased at the auction. This will be done strictly at the Purchaser's instruction, risk, and expense. Packing and handling of purchases are solely a courtesy, and the Purchaser will assume full responsibility in the event of damage resulting therefrom.
11. In the event that Tim's Inc. incurs any expenses or attorney's fees by reason of a breach of the Conditions of Sale or by reason of Purchasers failure to pay the full amount owing, the Purchaser shall be liable for such expenses and/or reasonable attorney's fees.
12. The Purchaser hereby submits to the jurisdiction of the State of Connecticut. All transactions between the Purchaser and Tim's Inc. shall be governed by the laws of the State of Connecticut.
